To complete your request to receive E-Statements and to stop receiving paper statements by mail, please read and consent to the agreements below by signing where indicated.

How to Stop Delivery of Your Paper Statement

You may request the additional convenience of eliminating delivery of the paper statement and checks enclosed with that statement. If you select this option, we will send an email to the email address you provide with your statement attached as a password protected Adobe PDF file. You may download the software here: <http://www.adobe.com/products/acrobat/readstep2.html> You can change the email address for the statement delivery at any time by contacting our customer service area and signing a new form. Each statement, together with any legal notice about your account, will remain available at least 12 months. You may also print the statements. There is no charge for this service. Some promotional materials will not be available.

Note: if you receive a combined statement for your accounts, once you select the lead account, you must also agree not to receive paper statements for all of the other accounts appearing on the combined statement. You will receive a single email reminder for the entire statement, and all of the information you currently receive will be available in the email statement.

By signing below, you consent to the electronic delivery of your periodic statements and all notices (including any change in terms) which are included with the paper statements. Your paper statement will be delivered for one statement cycle after today's date, and then you will no longer receive a paper copy delivered by mail. Copies of any checks you currently receive will be held by us pursuant to the Check Safekeeping Service as described in your account agreement. You may cancel your consent and again receive paper statements at any time by visiting customer service at any of our 6 banking locations or calling us at 1-800-994-3430. If you cancel, Check Safekeeping will still apply.

You may request a paper copy of any statement by contacting the phone number listed above. Charges may apply for paper copies. Please reference your applicable account agreement.
